GENERAL INFORMATION

COVERAGE

Approximately 150 to 200 sq. ft. Stain Delete can be diluted to 1 to 1 with water. For heavy stains use Stain Delete full strength. Apply Stain Delete to surfaces with sprayer or roller. Always rinse treated surface immediately after use. FOR CLEANING CONCRETE, STUCCO, CEMENT, TILE, WOOD, PLASTIC AND PAINTED SURRACES: Apply Stain Delete to dry surface, use enough product to wet surface thoroughly (slight application will not allow product to penetrate properly). Allow 3 to 5 minutes contact time, then rinse surface thoroughly with water. DO NOT LET PRODUCT DRY ON SURFACE PRIOR TO RINSING!
